1. Aims of the Accessibility Plan	
<p>This plan outlines how Leasowes aims to increase access to education for pupils with disabilities in the three areas required by the planning duties in the Equality Act 2010 (i.e. the curriculum, physical environment and information).</p> <p>A person is regarded as having a disability under the Act where they have a physical or mental impairment that has a substantial and long-term adverse effect on their ability to carry out normal day-to-day activities.</p> <p>This plan aims to:</p> <ul style="list-style-type: none"> • Increase the extent to which pupils with disabilities can participate in the curriculum. • Improve the physical environment of the school to enable pupils with disabilities to take better advantage of education, benefits, facilities and services provided. • Improve the availability of accessible information to pupils with disabilities. <p>The above aims will be delivered within a reasonable timeframe, and in ways which are determined after considering pupils' disabilities and the views of parents and pupils. In the preparation of an accessibility strategy, the Trust must have regard to the need to allocate adequate resources in the implementation of this strategy.</p> <p>The Trust also recognises its responsibilities towards employees with disabilities and will:</p> <ul style="list-style-type: none"> • Monitor recruitment procedures to ensure that individuals with disabilities are provided with equal opportunities. • Provide appropriate support and provision for employees with disabilities to ensure that they can carry out their work effectively without barriers. • Undertake reasonable adjustments to enable staff to access the workplace. <p>The plan will be resourced, implemented, reviewed and revised by Trustees in consultation with:</p> <ul style="list-style-type: none"> • Pupils' parents. • The Headteacher and other relevant members of staff. • Governors. • External partners. <p>This plan is reviewed every three years to consider the changing needs of the school and its pupils. The plan is also reviewed where the school has undergone a refurbishment.</p>

3. Roles and Responsibilities

The Governing Board in each school will be responsible for:

- Ensuring that all accessibility planning adheres to and reflects the principles outlined in this plan.
- Approving this plan before it is implemented.
- Monitoring this plan.

The Headteacher will be responsible for:

- Ensuring that staff members are aware of pupils' disabilities and medical conditions.
- Establishing whether a new pupil has any disabilities or medical conditions which the school should be aware of.
- Consulting with relevant and reputable experts if challenging situations regarding pupils' disabilities arise.
- Working closely with the governing board, LA and external agencies to effectively create and implement the school's Accessibility Plan.

The SENCO will be responsible for:

- Working closely with the headteacher and governing board to ensure that pupils with SEND are appropriately supported.
- Ensuring they have oversight of the needs of pupils with SEND attending the school, and advising the headteacher in relation to those needs as appropriate.

Staff members will be responsible for:

- Acting in accordance with this plan at all times.
- Supporting disabled pupils to access their environment and their education wherever necessary, e.g. by making reasonable adjustments to their practice.
- Ensuring that their actions do not discriminate against any pupil as a result of their disability.

4. The Accessibility Audit

The Trustees will delegate to Governors an Accessibility Audit whenever deemed necessary. The audit will cover the following three areas:

- **Access to the curriculum** – assess the extent to which pupils with disabilities can access the curriculum on an equal basis with their peers.
- **Access to the physical environment** – assess the extent to which pupils with disabilities can access the physical environment on an equal basis with their peers.

- **Access to information** – assess the extent to which pupils with disabilities can access information on an equal basis with their peers.

When conducting the audit, the Governors will consider all kinds of disabilities and impairments, including, but not limited to, the following:

- **Ambulatory disabilities** – this includes pupils who use a wheelchair or mobility aid
- **Dexterity disabilities** – this includes those whose everyday manual handling of objects and fixtures may be impaired
- **Visual disabilities** – this includes those with visual impairments and sensitivities
- **Auditory disabilities** – this includes those with hearing impairments and sensitivities
- **Comprehension** – this includes hidden disabilities, such as autism and dyslexia

The findings from the audit will be used to identify short-, medium- and long-term actions to address specific gaps and improve access. All actions will be carried out in a reasonable timeframe, and after taking into account pupils' disabilities and the preferences of their parents. The actions that will be undertaken are detailed in the following sections of this document.

Meet the individual needs of pupils during statutory testing.	Children are identified early and given the right intervention where necessary to ensure that they are prepared for all statutory testing in place. Where necessary, children are rigorously assessed and support, such as extra time or a scribe, are applied for and in place when needed.	Leading up towards all statutory testing	Children with specific needs to be assessed and provided with the correct support during testing. This may be additional time, scribe, 1:1 reader or modified tests e.g. enlarged print.

Target	Strategy	Timescale	Outcome/Impact
Complete final phase of roof replacement and polycarbonate roof windows	Submit a successful CIF bid to complete the remaining 25% of the roof and replace polycarbonate roof windows.	Sept 2026	Enhances the longevity and sustainability of the school building by reducing heat loss and supporting environmental targets through the installation of solar panels.
Rebuild walkway corridor	Include walkway rebuild in CIF bid alongside roofing works.	Dec 2026	Improves health and safety by ensuring the corridor is watertight and structurally sound.
Install shelter for parents	Provide covered waiting areas at Reception, KS1 and main office entrances.	Oct 2025	Offers parents protection from adverse weather, improving the arrival and collection experience.
Improve access to school office facilities	Widen entrance to accommodate wheelchairs and pushchairs.	Oct 2025	Enhances accessibility and inclusivity for all visitors to the school site.
Improve toilet facilities in the EYFS area	Refurbish and upgrade EYFS toilets to ensure they are age-appropriate, hygienic, and accessible. Include features that support independence, safety, and dignity for young children.	June 2026	Provides a safer, more comfortable environment for EYFS pupils. Supports early development of independence and improves overall hygiene and wellbeing. Enhances provision in line with statutory EYFS welfare requirements.

Provide families with rich, accessible communication through a variety of methods	Continue to develop and refine communication practices to ensure all stakeholders receive timely and effective information. Implement a new MIS system with app-based functionality to streamline communication. Ensure information is accessible via the school website, Twitter, School Money, email, telephone, text messaging, Family Learning programmes, assemblies, Parents' Evenings, 'Meet the Teacher' events, and parental workshops. Provide tailored support for parents with additional needs, such as sign language provision, to ensure equitable access.	Sept 2025	Strengthens parental engagement and ensures inclusive access to school communications. Enhances the overall effectiveness of stakeholder communication and supports a more connected school community.
Paper copies made available upon request	All correspondence available in paper copies upon request via the office.	Sept 2025	Access to accurate and up-to-date information on request.
